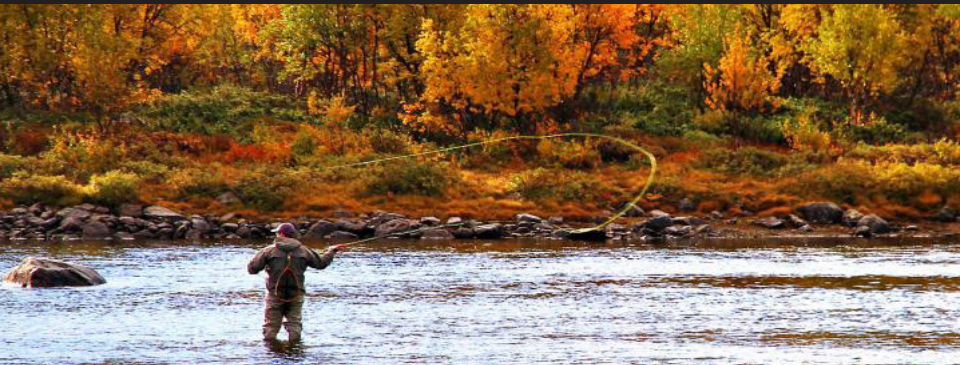


# *Taking Action: Advancing a Conservation Agenda*

In addition to addressing these issues, attendees will discuss the wide range of challenges currently facing America's sportsmen and women, along with the strategies necessary to overcome those challenges to protect and advance America's outdoor heritage, traditions, and sportsmen-generated conservation dollars in the years to come.

This year's Sportsman-Legislator Summit will be held at the Equinox Resort, located in Manchester, Vermont. The Equinox has over 200 years of history. It has been visited by four different American Presidents and served as a hotbed for American Revolutionaries; the Equinox today stands as a symbol of the history and lifestyle of New England over the past two centuries. Manchester Village is also home to the American Fly Fishing Museum, Robert Todd Lincoln's 412-acre summer estate (Hildene), and a wide variety of outlet stores for shopping and dining options, including many outlet stores and boutiques.
